Procurement Subject: Framework Contract for the Supply and Delivery of Network Switches for Three Years.

1. **Uganda National Roads Authority** has allocated/received funds to be used for the acquisition of *Framework Contract for the Supply and Delivery of Network Switches to UNRA for Three Years*.
2. The Entity invites sealed bids from eligible bidders for the provision of the above supplies.
3. Bidding will be conducted in accordance with the **Open Domestic Bidding** method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.
4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from **9:00am to 4:00pm**.
5. The Bidding documents in English may be purchased by interested bidders on submission of a written application to the address below at 8(b) and upon payment of **a non-refundable fee of Uganda shillings 100,000 (One Hundred thousand Shillings only) to a local bank**. The method of payment will be registering the payment on the Uganda Revenue Authority (URA) website portal. Print the payment advice Form after registering on the URA Portal and effect payment through the URA collection Banks.
6. Bids must be delivered to the address below at 8(c) at or before **6th December, 2019 at 11:00am**. All bids must be accompanied by a bid security of **UGX: 12,000,000/= (Twelve Million Uganda Shillings)**. Bid securities must be valid until **31st May, 2020**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **11:30am on 6th December, 2019**.
